

### BENJAMIN J. DEEN AND LIQUORI TATE SCHOLARSHIP FUND

#### **PURPOSE**

This fund was established to provide scholarships to full-time sworn Pine Belt law enforcement officers and their family members in cases where she/he is currently working as a full-time police officer or non-sworn employee of a police or sheriff's department within the Pine Belt area. Eligible family members include the officer's or non-sworn employee's spouse, children, step-children, siblings or other legal dependents of the officer.

Recipients must reside in the Pine Belt area and be a full-time student or non-sworn employee at any community college, college, university, or vocational school.

No funds from the Pinebelt Foundation may be used for propaganda purposes, to influence legislation, to influence the outcome of an election, or for direct or indirect use in a voter registration drive.

#### SCHOLARSHIP INFORMATION

Upon receipt of applications, the Benjamin J. Deen and Liquori Tate Fallen Officer Scholarship Selection Committee members will review each application. This Committee is comprised of Pinebelt Foundation Board Members, Law Enforcement Officers, and Community Leaders.

Applicants can reapply as funding becomes available. Applicants should keep in mind that the Pinebelt Foundation may receive more requests than can be funded.

#### **ELIGIBILITY**

In making a decision, The Scholarship Advisory Committee will use the following criteria:

- Applicants must be a family member (as defined above) of a sworn or non-sworn law enforcement officer currently serving in the line of duty.
- The sworn law enforcement officer must have been serving in their official capacity in law enforcement at the time of application in the Pine Belt of Mississippi (Forrest, Lamar, Jones, Marion, Perry, Jefferson Davis, Smith, Jasper, Wayne, Lawrence, Pike, Walthall, or Covington County).
- Acceptance to a community college, college, university, or vocational school.
- A minimum 2.5 GPA from a previous high school or college.
- Submit a 500-word typed and double-spaced essay titled "Why I support local Law Enforcement"

#### **NOTIFICATION**

Applicants will be notified by mail about the status of their application no later than May 15. Scholarship funds will be distributed directly to the institution of the applicant's choice no later than August 1.

#### **GUIDELINES**

Each complete application must be received by the Scholarship Advisory Committee by April 14.

- Completed application form
- Official high school and/or post-secondary school transcripts (Must be in an <u>unopened</u> envelope sealed by the school)
- If renewal application applicant must provide most recent transcript
